- 2) athletes with Belarusian or Russian passport as Individual Neutral Athletes

2024 EUROPEAN OLYMPIC SINGLES QUALIFICATION PROSPECTUS

All* athletes entered shall satisfy the following conditions:

- 1) Their National Olympic Committee (NOC) has not yet qualified in teams for the 2024 Paris Olympic Games
- 2) Players are eligible for participation in the Olympic Games, as per regulation 4.5.1. of the ITTF Statutes.
- 3) The maximum number of players a NOC may enter is equal to the quota places available to this NOC (each NOC can enter maximum two athletes per gender)

There is no obligation for the players to participate in the Continental Singles Qualification Tournament to be eligible for WR selection. The Qualification System intends to provide multiple opportunities for the athletes to qualify, not to oblige them to participate in all of them

- 4) The NOC needs to confirm the participation of the athletes entered by the Member Association through the NOC Confirmation Form
- * Russian and Belarussian passport holders may be entered at ITTF as Individual Neutral Athletes by signing and submitting the Additional Terms of Participation document within the ITTF/IOC deadlines (2 athletes per gender for Russian passport holders and 2 athletes per gender for Belarusian passport holders)

In the context of betting participants shall not, by any manner whatsoever, infringe the principle of fair play, show unsporting conduct, or attempt to influence the course or result of a competition, or any part thereof, in a manner contrary to sporting ethics. Any violation of this principle shall be disciplined according to provisions of ITTF Regulations 3.5.3.
