General changes in Propositions 3,4,5,7,8,9, 10,13 and 14

Propositions 3,4,5,7,8,9,10,13 and 14

The following points will be changed to adapt to changed situations or to simplify:

- Draw and Jury are unified in all regulations
- The competition manager will be jury member with voting rights
- The Jury will get legal power in all cases at the event which are not dealt with by the referee
- The Host association will not be obliged to reimburse ETTU for travel costs of the inspection visit. ETTU will cover these costs in future.
- Some wording is improved without changing the content.

The following points will be moved to the respective events' directives:

(in case of necessary changes it is easier to handle them without need of congress decisions)

- Date of the event
- Medals and honorary awards
- Flags and national anthems
- ETTU Event Management System
- Information on accessibility of rooms, provision of rooms... (Facilities)



Proposition 2 and Proposition 7

Proposition 2: Regulation B - International Eligibility

NEW

• For the European Veterans Championships, it is stipulated that players may **only register for** the country whose nationality they are, provided that the TT association of this country is a member of the ETTU. Residence of a player is not a proof anymore. Players are obliged to provide documentary evidence of their nationality upon request.

WHY?

• It is easy to verify the nationality of a player by checking the passport of the player and whether this is the nationality of a member association of ETTU.



Proposition 7 – European Veterans Championships

NEW

- The wording for eligibility is changed to eligibility only by nationality of a
 country which association is an ETTU member same as in proposition 2.
- The **new age category 90 and older** is included. Therefore the age category 85 and older is replaced by the age category 85-89.

WHY

- This change refers to the change in proposition 2.
- The new age category is implemented after the request of the Veterans committee.
 With this change the EVC has now the same age categories as the World Veterans (now Masters) Championships.



Proposition 3

European Championships (Individual Events)

Proposition 3 – European Championships Individual events

NEW:

- The fee of an individual player will be increased from 50 to 100 Euros, but:
- The extra fee for replacement of players will be deleted.

WHY:

- The costs have increased during the last 2 years enormously and the fee did not change since around 6 years.
- Additionally there shall be a difference to the fees for players in youth competitions (currently 50 Euros).



Proposition 4 European Championships (Team Events)

Proposition 4 European Championships (Team Events)

The EC Team Events shall be restructured especially regarding Stage 1 Groups A, B, C and Stage 2:

- Less dates for competitions
- Be played within one calendar year as THE EC Team Events (with Stage 1 and Final Stage)
- More teams directly qualified to Final Stage
- Keep the principles:
 - that a team starting in stage 1 can win the European Championships later in Final Stage.
 - · Give participating teams as many matches as possible.
 - EC shall be kept as the Continental Stage for qualifying to the WTTC Team Final.

WHY?

- The 2 editions have shown that the number of dates is a weak point too many dates which are too difficult to confirm
- In home and away matches not all teams present their best teams away which is difficult for host teams association in regard of marketing...
- Date for the second stage in May clashes with european and national club competitions and is also difficult in case WTTC is played in May.
- Costs are very high, (e.g. travels and accommodations)
- Sustainability can be better fulfilled with less dates with less travel necessities.

Proposition 4 European Championships (Team Events)

Stage 1

- > 5-6 days
- > Jan or Feb 2025
- ➤ 6 (5) teams qualify to Final stage
- ➤ 1000 Euros fee/team

Final Stage

- > 7-8 days
- October 2025
- ➤ 18 (19) teams directly qualified, pay 2000 € fee
- > 6(5) qualifier to Final stage (pay 1000 € fee)

The EC Team Events shall be restructured as follows:

- The EC will be played within 10 months in the year on 2 dates:
- 1st and 2nd Stage will be replaced by
- **EC Stage 1** Event of 5-6 days in January or February of the same year as the Final Stage (e.g. Jan/Feb 2025).
- All teams who want to play the EC and have not qualified directly to the Final Stage, must start in Stage 1 to be able to compete for 6 (5) places to the EC Final Stage.
- **Final Stage** remains as a 7-8 days event in October of a year (Oct. 2025)
- 18 best teams from previous EC (= Malmö) are directly qualified to the Final Stage of the next EC.
- If the host is not included in the 18 teams, the host will also be directly qualified (= 19 teams)
- Costs: 2000 € for Final Stage, 1000 € for Stage 1,
- The 6 (5) qualifiers pay 1000 € for Stage 1 and additional
 1000 € for Final Stage.

Proposition 6 – European Youth Championships Annex 1

NEW: Wording "European Ranking" instead of World Rankings

WHY: this gives ETTU the option to use either the European extract of Worldranking (like for U 19 and seniors) or to use the separately made European Ranking (like for U 15 and U 13)

NEW: The Ranking committee can give extra points to **single** players

WHY: To correct in case players are high ranked in world ranking but are low ranked in european ranking. May be necessary if young players play many WTT Youth events but seldom ETTU youth series events.

NEW: In the Prospectus of the EYC it must be specified which rankings are used for the EYC.

WHY: To be transparent which exact ranking will be used (this is already the case in other events).



Proposition 9
Europe TOP-16 Cup

Proposition 9 – Europe TOP-16 Cup

NEW:

- the winner of the previous TOP 16 Cup is qualified to the next TOP 16 Cup.
- Hosting levy will be 15.000 Euro

WHY:

- The winner shall have the opportunity to defend his/her title in the next TOP 16 Cup –
 even if he/she is not 1 of the 2 highest ranked players of an association. That association
 can then only qualify one additional player by ranking.
- According to the regulation the levy will be increased from 10.000 to 15.000 Euro. The
 levy of the previous edition was 20.000 Euro (by event agreement) and the new
 regulated levy is the medium cost.



Proposition 11 and 12

European Club Competitions Men and Women

Propositions 11 and 12 European Club Competitions Men and Women

NEW:

- The Table Tennis Champions League will be renamed to European Champions League MEN
- No management boards anymore instead of this at least once a season there will be a
 meeting with all participating clubs of the ECL men and ECL Women
- Outdated text (like J 4.4 old) will be deleted
- Juridical adapted to Constitution

WHY:

- Old name not good for European competition better to have european in to indicate ETTU, and to refer to the ECL Women
- Instead of only involve representatives from 3 clubs ETTU will include ALL CLUBS to get their opinions therefore not necessary to have Management boards.
- This rule was not used anymore, team ranking is done by results in ETTU Club competitions.



Proposition 14

European Under 21 Championships

Proposition 14 European Under 21 Championships

NEW:

- The host association gets 2 men and 2 women spots guaranteed
- The hospitality arrangements have to be booked through the host association.

WHY:

- With 2 spots each men and women the host association can form doubles, which are part of the EC.
- The possibility for delegations to book own hospitality arrangements will be deleted because so far no association used this option and:
- The host association is better able to plan the budget and host the Championships.
