7. Eligibility

Open to the players of the European National Olympic Committees (NOC) which must enter the players through the respective ETTU member Associations.

All players entered shall satisfy the following conditions :

- 1) Their National Olympic Committee (NOC) has not yet qualified their maximum quota for the 2020 Tokyo 2020 Olympic Games Singles Events
- 2) Players are eligible for participation in the Olympic Games, as per regulation 4.5.1. of the ITTF Handbook.
- 3) The maximum number of players a NOC may enter is equal to the remaining quota places available to them.

17. Transport

18. Medical service

Permanent medical service (first aid and physiotherapist) will be provided in the hall during the whole period of the tournament.

19. Insurance

By entering the event, each Association must ensure that all delegation members have medical, travel and other appropriate insurance.

20. Video

Each participating Association will be allowed to use one video camera for recording matches of their own players. For using other video cameras a fee of 20 EUR shall be paid for the period of the tournament. Video is only for own use. It is forbidden to post videos online.

23. Levy

There shall be a levy of 100 € per participating player, payable to the ETTU.

24. Information for players

By entering the event, players agree to abide by all ITTF and ETTU rules and regulations. All entered Associations and individual players agree to be under the auspices of the ETTU and its agents in all matters concerning television coverage, video, internet web casting, motion picture coverage, and photographic coverage of any kind. Participants release all rights, or rights held by their agents or sponsors, in all matters relating to television and web casting coverage, video and motion picture coverage, and photographic coverage of any kind. A participant's refusal of the coverage listed above may be subject to suspension or dismissal from the competition.

25. Information for participants

In the context of betting participants shall not, by any manner whatsoever, infringe the principle of fair play, show unsporting conduct, or attempt to influence the course or result of a competition, or any part thereof, in a manner contrary to sporting ethics. Any violation of this principle shall be disciplined according to provisions of ITTF Regulations 3.5.3.

26. Racket control

There will be random racket tests.
